YOUR USE OF THE SERVICES ORDERED FROM ASTRO USING THE ASTRO PORTAL IS SUBJECT ACCEPTANCE OF ALL APPLICABLE LICENSE TERMS, INCLUDING THE LICENSE TERMS OF THIRD-PARTIES THAT ASTRO PRESENTS TO YOU.

Applicable License Terms

If You use Astro Services, You agree that the following license terms apply:

Use of API to Access Astro Services: To access the Services, You or a User of the Service may be required to use or address an Application Protocol Interface (API) that is provided by Astro or under license by Astro. Your use of any API you download from Astro is governed by the license terms included with the code.

To access the Astro Services, you may be required to use an API licensed to Astro by one or more of Astro's Vendors. You agree to use or access the software or other elements described under the following terms. These terms apply to the Software and other properties used to facilitate Astro and You access to and use of: (i) proprietary application programming interfaces or file system access specifications and protocols (collectively, Astro's Vendor's API); (ii) developer kit materials, such as sample code, for use in connection with the APIs, design and functional specifications, development and maintenance manuals, Astro's Vendor's API guides, and other technical information; and (iii) product specifications, user manuals, installation guides, whitepapers, made available to Astro by Astro's Vendors in connection with Astro's and Your access to and use of Astro's Vendor's Services. Distribution of the API and other materials described (the "Astro's Vendor's Software") to You by Astro is pursuant to a license by Astro's Vendor to Astro and is subject to the terms of that license. Astro's Vendor's Software means Software that Astro licenses from Astro's Vendors and includes source code, wrappers, and libraries, if applicable, that Astro's Vendors may make available from time to time to facilitate Astro's and its and Your access to and use of the Services. The Astro's Vendor's API, Astro's Vendor's Software and other materials provided by Astro to You with the Service are provided under the following terms:

Astro grants You a personal, non-transferable and non-exclusive license (without the right to sublicense) to use Astro's Vendor's API, Astro's Vendor's Software, in object code form solely for the purpose of enabling You and Your Users to make authorized use of the Services solely in accordance with applicable written and electronic documentation. Except as expressly authorized herein You shall not copy, modify, enhance, change or make derivative works of the Astro's Vendor's API, Astro's Vendor's Software, or any portion thereof. API and Astro's Vendor's Software by You or any User of Yours is required for the use of Services, You and Your Users may use the Astro's Vendor's API and Astro's Vendor's Software licensed to You under this Agreement for that purpose. You shall assure that Your Users comply with these terms and conditions. The term of the license granted hereunder shall be coterminous with the term of the related Services.
